





The following is an overview of what to expect during the system conversion weekend beginning on **Friday, February 17, 2023**. The conversion will be completed on **Tuesday, February 21, 2023**.

ATM Access	Beginning at 5 p.m. on Friday, February 17, 2023, ATMs will be available for cash withdrawals only. Full ATM functionality will resume on Tuesday, February 21, 2023.
ATM/Debit Cards	• There will be no change to your current ATM/Debit Card. Please continue using your current PCSB ATM/Debit Card as normal.
Branches	 PCSB Branches will be open for normal banking hours on Friday, February 17, 2023. PCSB Branches will be closed Saturday, February 18, 2023, through Monday, February 20, 2023, for the system conversion, and will reopen for normal banking hours on Tuesday, February 21, 2023.
Checks	You may continue to use your current PCSB Bank checks following completion of the system conversion.
Direct Deposit & Automatic Payments	Direct deposit and automatic payments will continue to be processed without change.
Loans	The terms of your loan will not change. A separate Notice of Servicing Transfer will be mailed to all consumer mortgage loan customers before February 2, 2023. Home Equity LOC and Credit Reserve customers will receive more time to make your loan payment. Beginning with your first statement issued after February 18, 2023, your payment due date will now be twenty-five (25) days from the date the statement is issued. FRIDAY, FEBRUARY 17	 All PCSB Bank Branches will be open for normal business hours. Beginning at 5 p.m., ATMs will be available for cash withdrawals only. The last Bill Pay payment for business and commercial customers will occur at 1 p.m. Online & Mobile Banking will be available for balance inquiries only as of 5 p.m. Bill Pay for current PCSB personal banking customers will be unavailable as of 5 p.m. At 5 p.m. Telephone banking will be available for balance inquiries only.
SATURDAY & SUNDAY, FEBRUARY 18-19	 PCSB Bank Branches will be closed. Call Center support will be available from 8 a.m. to 2 p.m. at 888-808-4700 on Saturday, but closed on Sunday. PCSB Bank ATMs will remain available for withdrawals only. Telephone banking will be available for balance inquiries only. Online & Mobile Banking will remain available for balance inquiries only.
MONDAY, FEBRUARY 20 (PRESIDENT'S DAY)	 PCSB Bank Branches will be closed. Personal and Small Business Banking customers can log into and access the new PCSB Online & Mobile Banking and Bill Pay. You may also download the new PCSB Bank-NY mobile app. Telephone banking will be available for inquiries only.
TUESDAY, FEBRUARY 21	 PCSB Bank Branches will be open for normal banking hours. ATM access will resume full functionality. The Call Center will be available beginning at 8 a.m. Hours for the Call Center may be found at pcsb.com. Telephone banking will be available at 8 a.m. Zelle® will be available in Online & Mobile Banking for personal banking customers.
